



Size of practice based on annual gross turnover






Regional Distribution












Size of office floor area in m²





Breakdown of turnover from and time spent on services






Breakdown of time spent on all tasks in an accounting practice





Turnover change





Causes / Reasons for Turnover Change







Figure 11: Age of Staff














Day-to-day collection of fees










