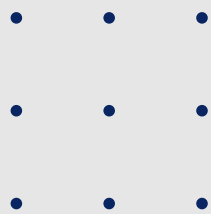

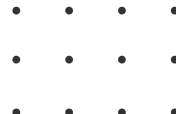

Dr. Michael Nokokure Humavindu is currently Deputy Executive Director: Industrialisation and Enterprise Development at the Ministry of Industrialisation, Trade and SME Development, Namibia.

Previously he served as Director: Economics and Sector Research at the Namibian Competition Commission. He also served as the Manager of Research at the Development Bank of Namibia and as an Economist in the Ministry of Environment and Tourism in Namibia.

These work experiences has exposed him to developing skills in Industrialisation strategy and Policy, National Investment policy and regulations, Development banking, Enterprise and MSME sector development, Natural resource & biodiversity economics, regional and national Sector value chains development, Informal economy and Startups sector development and Project finance appraisals.

He has also published some of his research as peer-reviewed journal articles.

Dr Humavindu is currently serving on the boards of Namibia University of Science & Technology (NUST), Agribank of Namibia and the Peugeot-Opel Assembly Namibia (POAN). Dr Humavindu is also a member of the Ministry of Environment and Tourism's Nature Conservation Board.

Dr. Humavindu is founding chairperson of the Environmental Economics Network of Namibia (EENN). Previously he served on the Boards of Namdeb Holdings, Debmarine Namibia and the National Sustainable Development Advisory Committee.

Dr. Humavindu holds a PhD (Economics) from the University of Umeå, Sweden, an MSc (Finance & Investment) from Durham University, United Kingdom and a MA (Economics) from Stellenbosch University in South Africa. Dr Humavindu also attained the credentials of a Certified Development Bank Executive (CDBE) through the Asia-Pacific-Institute of Development Finance.
