According to the NPO Directorate from the Department of Social Development (DSD), 50% of 250 000 NPOs are on the verge of deregistration due to non-compliance with filing annual reports and poor financial record keeping and controls.

The DSD has officially started their deregistration campaign.

This is a direct call to accountants to step up and assist.

The NPO Act requires that all registered NPOs appoint an accounting officer to hold office. Chapter 1 of the NPO Act defines an accounting officer in relation to a nonprofit organisation, as a person contemplated in section 60 of the Close Corporations Act, 1984. Chapter 6 of the Companies Act, 2008.

CIBA's designation, Business-Accountants-in-Practice (SA) or BAP(SA) qualifies to serve as an Accounting Officer. The License was tailored specifically for the non-profit sector and will provide accountants with valuable knowledge and practical skills that can be used instantly to make meaningful impact on NPOs and access new clients.
